## FAREWELL REFERENCE SPEECH OF JUSTICE ALEXANDER THOMAS

Dated: 25.08.2023

Hon'ble the Chief Justice of this Court, Sri.Justice Ashish J Desai, my esteemed Sister and Brother Judges of this Court, distinguished former Judges of this Court who are present, learned Advocate General, Presidents of the Bar, Senior Bar and Women's Bar, Chairman of the Bar Council of Kerala, distinguished law officers of the State and the Union, esteemed members of the Bar and the Senior Bar, members of the Registry and the staff of this Court and its allied organizations, Advocate Clerks, my family members, Ladies and Gentlemen;

## Good afternoon to all,

- 1. I wish to convey my sincere gratitude for the kind and considerate words spoken about me by the Hon'ble Chief Justice, the Learned Advocate General as well as the President of the Bar. However, it would be unbecoming of me to leave without expressing my heartfelt appreciation to all of you.
- 2. On this significant occasion, I extend my gratitude to the Hon'ble Supreme Court Collegium, led by the then Chief Justice of the Supreme Court, Sri. Justice P. As I step out from this position, I wish to leave you with the conviction that my own journey has reaffirmed the truth: it is not just the Bench, but the

members of the legal fraternity who are the high priests of law and the last bastion of democracy.

- 13. A Court is not merely a building; it is a beacon of hope, a sanctuary for the pursuit of truth, fairness, and the protection of rights. For the past three decades, the High Court of Kerala has been more than just a workplace; it has been my second home, a place where justice is being pursued with unwavering dedication. As dedicated members of this esteemed family, every judge and official within this institution are tirelessly working to enhance the High Court's operations. As I step out from my role as a judge of this Court, I wish to convey my sincere gratitude and immense pride for the transformative initiatives spearheaded by the various committees of this Court.
- 14. I may also take this opportunity to count the various blessings that the Divine Providence has bestowed on me. One such blessing given by the Divine Providence and Mother Earth, that I could greatly enjoy is the Mangalavanam Bird Sanctuary area, near to our High Court, where I make my regular morning walks. The abundant gifts of tranquility, serenity and fresh air that Mother Earth could bless me through Mangalavanam have never ceased to comfort me and infuse me with vitality. I am profoundly grateful to the Divine Providence and Mother Earth for providing Mount Agastyaarkoodam (which is believed to be the abode of Sage Agastya), Mount Maruthwamala (where Sree Narayana Guru has attained

enlightenment), and Mount Anaimudi (the tallest peak in South India), which I have been fortunate enough to ascend on occasions more than one.

I am equally thankful for the enchanting Lake Sasthamcotta. These expeditions have enlarged my vistas and horizons of Ecosophy, the wisdom of Mother Earth.

Before parting, I would also like to flag a very serious issue of the 15. agenda of future development of our High Court. As all of you are aware, we had shifted our High Court to this new building in 2006 and the State PWD authorities, after due consultations with the experts at the Indian Institute of Technology (IIT), Chennai, have informed that it is impossible for the vertical expansion of the existing High Court building. This stultifies the future development projects of the High Court. A consistent plea has been made by our High Court to the State Government authorities at the higher level, that the nearby land area of 17.73 acres, near to Mangalavanam, which is currently under the possession of the Kerala State Housing Board, be allotted to our High Court for impending expansion needs. The issues of eco-sensitive objections, pertaining to the above land, have now been overcome by the recent verdict of the Apex Court. The demand of the High Court for the above land area near to the Mangalavanam is fully justified, as there is no availability of other suitable vacant land in the proximity of the High Court. Recently, another objection has been raised, on behalf of

the Govt. Department concerned, that the aforesaid land, now under the possession of the Kerala State Housing Board, may have to be used for establishing an exhibition centre or such other commercial centre. It does not require any elaborate exaplanation that the needs of the judiciary, in carrying out its sovereign functions, would certainly, far overweigh the proposed requirements of any such commercial venture, which can easily be accommodated in other lands that may be allotted by the Government in other nearby areas in Ernakulam, like Kalamassery, Kakkanad, etc. Therefore, in my role as the Acting Chief Justice of this Court, I had written a DO letter to the Hon'ble Chief Minister, pointing out these vital asepcts and has requested that the Hon'ble Chief Minister may intervene in the matter, so that the abovesaid land of 17.73 acres near to Mangalavanam area is allotted to the High Court for its immediate development requirements. It is also very heartening to note that in the Chief Justice - Chief Minister meeting, held on 24.09.2022, the Hon'ble Chief Minister has positively given an assurance that the proposal for allottment of the above land to the High Court will be considered. Recently, on being apprised of this vital requirement, our Hon'ble Chief Justice has proactively responded and as directed by his Lordship, the Hon'ble Chief Justice, Hon'ble Justice Muhamed Mustague and myself have inspected the above land with the assistance of Revenue officers on 19.08.2023.

- organisations, like the KELSA, Mediation Centre, etc., are highly inadequate, compared to the facilities given by the other States, particularly, other High Courts. Therefore, I would call upon the Hon'ble the Chief Justice, the members of the Administrative Committee of the High Court, the learned Advocate General and also all the learned members of the bar to immediately realise the gravity of the situation, so that all of you can jointly and collectively take up the matter with the Hon'ble Chief Minister for immediate action for allottment of the abovesaid land. I am sure that the Government would be fully alive to our concerns and would take a proactive and positive approach to meet the abovesaid vital requirements of our High Court.
- 17. Now, the ship has come to a halt, signalling my turn to step ashore at the harbour. A fresh adventure beckons me and the next ship eagerly awaits my embarkation. The juncture has emerged for you to carry on with this voyage in my absence and I entrust you with its continuation, with pride and confidence. Once more, I want to convey my deep appreciation for this remarkable expedition and the honour of partaking in it alongside all of you. I truly hope that the different journeys ahead, for both me and all of you, will be brimming with even more adventures and wonderful experiences. Farewell and onward to new horizons!
