Writ petition (civil) praying inter alia that in the circumstances stated in the affidavit filed along with the WP(C) the High Court be pleased to direct respondents 1 and 2 to declare a moratorium on all land deals in Devikulam, Udumbanchola and Peerumedu taluks in Idukki district and to stop all constructions sanctioned at Chinnakkanal, Pallivasal, Devikulam, Udumbanchola and Peerumedu taluks in Idukki district until an inquiry was held into the genuineness of the title deeds, pending disposal of the writ petition in the interest of justice.

ORDER

A. Muhamed Mustaque, J.

These Public Interest Litigations have been pending before this Court for more than a decade. By virtue of an interim order passed by this Court, as early as on 21.01.2010, utilization of land in ecologically sensitive areas in Munnar, Idukki District have been regulated and constructions have been permitted only in areas where the Revenue Authority has issued No Objection Certificates (NOC) to the owners, permitting such larger reliefs sought in these writ The petitions reflect the lethargy on part of the administration in dealing with the encroachments and regulating constructions in There is no master plan to make constructions the Munnar area. eco friendly. The Union Government also issued notification declaring certain areas as environmentally sensitive zones. Constructions without an Environment Management Plan will betray the hopes of the next generation. The Environment Management Plan can minimize and mitigate environmental effects in these areas. Without adverting to the nature of land, constructions have come up in the Munnar area, causing threat to ecology as well as to humans. Wayanad is another district in the State which is considered as

ecologically sensitive area where the District Collector stepped into action and regulated the construction of high rise buildings by invoking the provisions of the Disaster Management Act. However, in the ecologically sensitive areas in Munnar, so far, no actions have been taken by the District Administration or the State Administration to regulate such constructions. After obtaining No Objection Certificate from the Revenue Authority, constructions have been allowed, unmindful of the consequences thereon. No studies, so far, appear to have been conducted by the State to decide upon the nature and extent of the constructions, etc. which can be permitted in these areas.

- 3. We also appoint Senior Advocate Renjith Thampan and Advocate Harish Vasudevan as amici curiae to assist this Court.
- 4. Registry shall serve a copy of this order to the above local authorities, except the local authorities for which there are Standing Counsel in this Court. Each Local Authority shall state before this Court the details of the applications pending consideration, for construction of buildings, with the details of floors etc.
- 5. In the meanwhile, we direct the above defer the consideration of authorities to any pending applications for building permits beyond three floors, for a The details of the building permit period of two weeks. applications pending shall be furnished by the local authorities before this Court by the next posting.
- 6. The learned Government Pleader as well as the amici curiae shall state before this Court the agencies which could undertake studies in regard to the sensitive nature of the areas and to regulate construction, keeping in mind both ecological and disaster management aspects by the next posting.
- 7. The learned counsel appearing for the petitioner in one of the connected matters placed before this Court an order

passed by the Government on 20.04.2023, whereby, the Government constituted an expert committee for the formation of the Munnar Hill Area Development Authority.

- 8. The learned Government Pleader shall state before this Court whether any study has been undertaken by the Geological Survey of India after the flood in the year 2018 in these areas. If such a study has been undertaken, a report shall be made available before this Court by the next posting.
- 9. Amici Curiae be given copies of W.P(C) Nos.34095/2007, 1801/2010 & 19219/2021 free of cost.
